## **Jury Process**

### **The artist retains this page for his/her information**

The jury committee consists of four members, including the chair. The committee meets in the Broadway Gallery at 6:00 p.m. on the fourth Thursday of every month, excepting if that Thursday is a holiday. Then the committee will meet on the third Thursday of the month. The categories for jurying are:

1. Ceramic
2. Photography
3. 2-D - Painting and Drawing
4. Jewelry
5. Fiber
6. Wood
7. Glass
8. Sculpture
9. Print-making
10. Miscellaneous

### **What you need to bring:**

3 pieces of work in each medium in which you are jurying. The work must be matted, framed, or ready for display and priced. We are looking for artists ready to sell and with a cohesive body of work.

### **The Jury Process**

1. Be prepared to do a short, casual presentation of your work – usually around 10-15 minutes. Also tell the committee about other skills you can bring to a co-op such as marketing expertise, computer knowledge, carpentry, money-handling, etc.
2. Be prepared for a brief question period afterward.
3. Be prepared to leave your artwork with the committee until the following Wednesday. The committee will take its recommendation for acceptance or rejection to the next member meeting on the following Tuesday where the members will vote. You will be notified by email of your acceptance or rejection within 24 hours.

### **The work will be evaluated on the basis of**

- Competency with the medium. Are the techniques advanced? Is the medium used in an interesting way?
- Originality-Is it unique? Is it “fresh” and not copied from someone? Is it different from the work at the Broadway Gallery?
- Presentation – is the overall presentation professional looking? Quality frames and framing technique? Attractive display?
- Salability – is it something that will sell at the Broadway Gallery?
